
AGREEMENT BETWEEN THE SKOKOMISH INDIAN TRIBE AND THE WASHINGTON DEPARTMENT OF FISH AND WILDLIFE REGARDING AREAS SUBJECT TO THE CO-MANAGEMENT AGREEMENT OUTSIDE OF THE AREA IDENTIFIED IN THE ORIGINAL AGREEMENT (APPENDIX B)

Per Article IX.A of the HUNTING CO-MANAGEMENT AGREEMENT BETWEEN THE WASHINGTON DEPARTMENT OF FISH AND WILDLIFE (WDFW) AND THE SKOKOMISH INDIAN TRIBE (Tribe), this amendment serves as written agreement between the Tribe and WDFW that:

- The Tribe asserts that its members have traditionally hunted on lands near the headwaters of the Wynoochee and Humptulips Rivers.
- Areas where Tribal hunting has occurred have been documented by the Tribe and corroborated by the Quinault Indian Nation.
- For enforcement purposes, the boundaries of the area subject to the agreement in the southern region are described as:
 - North: The northern boundary of Game Management Unit (GMU) 636 (Skokomish); all of GMU 636 is included
 - Northwest: Forest Road 2204 (Campbell Tree Grove Road); from there, connect to the West Fork of the Humptulips River, then to the western boundary of GMU 636 (Skokomish); that part of GMU 638 (Quinault Ridge) east of Forest Road 2204 is included
 - West: Wynoochee Valley Road; from there, connect to Donkey Creek Road (GMU 648 northern boundary); the part of GMU 648 (Wynoochee) east of Wynoochee Valley Road is included
 - South: Follow Highway 8 east from Wynoochee Valley Road to Highway 12; from there, follow Highway 12 to the C-Line; travel 9.8 miles easterly, then turn northeast on the C-4000 road; travel 6.2 miles on the C-4000 road, then follow the B-5000 road northeasterly; travel 4.0 miles on the B-5000, then take a right onto the B-Line; travel on the B-Line for 2.6 miles to State Highway 8 (Rock Candy Entrance); that part of GMU 651 (Satsop) north of Highway 8 is included; that part of GMU 663 (Capitol Peak) north of the described boundary is included (see attached map).


AMENDMENT 2
