MASTER HUNTER CODE OF ETHICS

I will assume a leadership role among my peers and will do so by exhibiting exemplary conduct in the field. As a Master Hunter, I shall play a key role in improving relationships with all landowners, thus ensuring continued hunter access to private and public lands. I pledge to continue to expand my knowledge of wildlife and natural resource management practices and understand the role I play in these practices.

I pledge to be a "Steward of the hunt."



MHPP History

- 1992: Advanced Hunter Education program created
- Initial success, improvements identified
- Dec 2007 Commission policy to develop the MH program
- 2008 Commission adopted rules
- 2009 Legislative authority passes
- 2013 Hunter Education moves to Wildlife Program and drafts Wildlife Policy statement

MHPP Mission

Designed to:

- Promote safe, ethical, responsible, and legal hunting
- Promote support in the general public for hunting
- Promote the highest standards of hunting
- Enhance landowner-sportsman relations
- Engage applicants and participants in volunteer conservation projects that benefit wildlife and habitat, and promote hunting access on private lands
- Develop a corps of MH that can address sensitive wildlife depredation issues

MHPP Statutes and Rules

- RCW 77.15.760 Suspension of a master hunter permit – Appeal hearing
- RCW 77.32.570 Master hunter permit program – Fee
- WAC 220-412-030 Master hunter permit program

Commission Policy, Dec 2007

- MHs are a tool employed by WDFW to help resolve certain human/wildlife conflicts
- MH certification is a privilege, not a right
- Violations of any Department regulations will not be tolerated
- MHs are role models for the rest of the hunting community
- Act as ambassadors for the Department

Wildlife Program Policy

- Wildlife Program Policy builds on commission policy
- MHs are "Stewards of the Hunt" and give back to the wildlife resource
- Wildlife Program staff work to:
 - I.D. meaningful MH volunteer opportunities that promote conservation and address priority needs of the agency
 - Coordinate and manage MH volunteer efforts

Wildlife Program Policy Continued

- Focus areas for volunteer projects:
 - Increase hunter access to private lands
 - Increase hunter recruitment and retention
 - Protect and enhance important habitat
 - Participation in citizen science/wildlife data collection
 - Serve as an administrative or coordination role for a volunteer network

New Applicant Requirements

- Attend a Crime Observation Reporting Training (CORT) class
- Shooting proficiency
- Minimum of 20 hours of approved wildlife conservation work
- Pass a Background check
- Pass 100 question test
- Sign the Master Hunter Code of Ethics
 Agreement

Helpful hints to MH completion

- Take a CORT class ASAP
 - If you can't find a class near you, contact the regional Eyes In The Woods CORT training coordinator
- Study all of the materials for the test
 - You have two chances to pass
 - Minimum of 7 days between test retakes
- Start working on volunteer service early
 - Some applicants wait too long and do not complete the required hours

Certification

- Certified for five (5) years
- Congratulations letter, patch, and MH card will be sent to you
- After certification MH can put in for MH special permits and hunt general season MH only hunts

Re-Certification

- Can apply for recertification up to six (6) months before expiration of MH permit
- Must have completed 40+ hours of volunteer service over past five (5) years
- Pass a background check for RCW77.15
 violations in last five (5) years

Volunteer Opportunities

- CERVIS system, MH Newsletter, and Volunteer conservation website helps pinpoint WDFW needs
- WDFW projects are always a priority
- Make sure to show up to commitments
 - If unable to make it, contact the volunteer supervisor.
- MH cannot volunteer on their own property

CERVIS

- Online Volunteer Portal
 - Lists available projects
 - Tracks service hours
- Can be used instead of paper forms for MH service hours
- Use is encouraged and will become more common in the near future


Volunteer Opportunities

The Washington Department of Fish and Wildlife welcomes volunteers who want to assist in activities that benefit fish, wildlife and habitat.

A variety of volunteer opportunities are available, including projects on state wildlife areas, water access sites, furthering conservation activities and hunter education through the Master Hunter program, and local projects that benefit salmon recovery through Regional Fishery Enhancement Groups (RFEGS).

Beginning in 2012, WDFW implemented an on-line volunteer management system to make it easier for volunteers to learn about volunteer opportunities and to participate in them. Known as CERVIS (Community Event Registration & Volunteer Information System), this system tracks projects and volunteer hours

First, potential volunteers must register using a simple on-line form; then review the volunteer opportunities that are available.

Expectations of MHs

- Represent themselves, our hunting heritage, WDFW policies and decisions, and the MHPP with the utmost professionalism
- Follow all state and local laws pertaining to hunting, use of firearms, fishing, and other outdoor recreational activities

- Have hunting equipment sighted in prior to hunting and be EXTREMELY proficient in its use
- Be knowledgeable of animal anatomy and correct shot placement for a humane harvest
- Be able to field dress any harvested animal effectively

- Be an ambassador of safe, ethical, responsible, and legal hunting
- Behave as role models of ethical hunting
- Give back to the resource through volunteer work and promote safe and ethical hunting

- Assist the Department in resolving certain human/wildlife conflict situations
- Be willing to help create good will between WDFW and landowners by volunteering
- Mentor hunters who may be new to hunting or a particular species

- Improve the image of Master Hunters through their attitudes and actions
- Self-report any fish and wildlife violations
- Maintain correct contact information with WDFW
- Follow through when signed up to volunteer

Wildlife Conflict and Damage Control Activities



WDFW is Responsible For Managing Wildlife Damage to Crops on Private Land

The Master Hunter Permit Program will not function as intended if it doesn't work for the landowner.

WDFW Conflict Management Goals

- Minimize damage caused by wildlife
- Move wildlife off private property
- Modify the behavior of wildlife causing damage

Strategies to Meet Conflict Goals

 Use of MH is one method to help prevent damage caused by wildlife to private and public lands

• If using MH is not the appropriate method, conflict staff can use other tools to address damage

Strategies to Meet Conflict Goals

- MH general seasons
- Second tag MH special permits
- Second tag for Elk Area 3911 to encourage early season hunting pressure and harvest
- Landowner permits
- Hazing

Landowner Permits

- Damage Prevention Permits
 - Issued to landowner
 - Landowner can harvest or select another licensed hunter
 - Landowner may charge access fees
- Kill Permit
 - Only for landowner and immediate family

Roles for MH General Seasons

- Game Division
 - Presents rules to the Commission for setting general hunting seasons
 - May post activity updates to the website to assist in control activities

Roles for MH General Seasons

- Landowners
 - May allow access to their property if approached in advance. Some welcome MHs. Volunteer projects may help MHs make contacts.
 - ARE NOT REQUIRED TO ALLOW ACCESS. Trespassing is a big problem in some MH general seasons.

Roles for MH General Seasons

- Master Hunter
 - Scout and know the area prior to season
 - Make efforts to meet with landowners for access
 - Take safe, effective shots that will result in a quick and humane harvest. The property next door may not let you recover a harvested animal
 - Be self-sufficient in recovery of animal
 - Be proficient with chosen hunting equipment and field dressing

Roles for MH General Seasons

- Master Hunter continued
 - Plan your hunt activities with these goals in mind:
 - Move animals away from agricultural areas into wildlife area/winter grounds
 - Limit damage to fencing
 - Improve the image of MHs
 - Be aware that you are being watched by the public
 - Keep to your highest ethical standards

Helpful Hints



- ID property owners through county assessor's web page
- Contact landowners well in advance of the season to secure access
- Pursue volunteer opportunities through WDFW Coordinators

REMEMBER

- Adhere to landowner's directions and rules
- Landowners are <u>not</u> required to allow access

Landowner Contacts

- Dress appropriately when contacting landowners
 - No derogatory terms or messages
- Be professional
- Be courteous
- Thank them for their time

- Wildlife Conflict Specialist
 - Monitor damage caused by wildlife and develop a plan to address
 - Work with landowners
 - Deploy MHs drawn in the special permit drawings to remove wildlife causing damage
 - Direct activities of volunteer hunt coordinator (if used)

- Landowner
 - Allows MH to participate in removal of an animal on their property
 - Works with the Conflict Specialist to specify areas, notes safety concerns
 - Controls access landowners can choose whom they want on their property

- Volunteer Hunt Coordinator
 - Follows the direction from the Conflict Specialist
 - Calls the MH on the list as directed by Conflict Specialist
 - Arranges the hunt per the directions of the Conflict Specialist

- Master hunter
 - Must follow the directions of the Conflict Specialist, Hunt Coordinator, and landowner
 - Any failure to follow directions may result in removal from the property
 - Be able to the best of your abilities to respond to a deployment quickly
 - Preemptively talk to employer and family about the possibility of deployment

- Master hunter continued
 - Must be EXTREMELY proficient in the hunting equipment required for the hunt
 - Must be prepared to take care of the animal harvested, from field to freezer Do not expect the hunt coordinator, landowner, or WDFW staff to provide assistance
 - Don't contact Conflict Specialist about position on list

Expectations of MH on damage removal

- Represent hunters with the utmost professionalism
- Understand damage removal hunts are designed to move animals from areas of low tolerance to areas of high tolerance
- Follow all state and local laws pertaining to hunting and use of firearms

- Follow all conditions set forth by the Wildlife Conflict Specialist (WCS), Hunt Coordinator (HC), or landowner
- Strictly adhere to any mandated shooting lanes or other restrictions indicated by the WCS, HC, or landowner
 - Safety always takes priority over the harvesting of any animal

- Refrain from contacting WDFW
 personnel regarding the permit list and
 the Master Hunter's status on the list
- Be at the property within the deployment timeline
- Provide high hunting effort, over several days, and possibly under difficult conditions

- Vehicle access to the property may be severely restricted or prohibited
- Be EXTREMELY proficient in the use of the hunting equipment required
- Pass on hunts for which they are not qualified
- Be able to field dress any harvested animal efficiently

- Have all hunting equipment sighted in for hunting prior to arrival at the hunt location
- Be knowledgeable of animal anatomy for removal and the correct shot placement for a quick and humane harvest

Damage Permit Level Changes

- 2017 permit levels lower than in2016
- Permit levels decreased due to
 - WDFW effort to "right size" the number of permits relative to need
 - Convey more realistic expectations to MHs

Special Hunt Permit Points

- If MHs don't have an opportunity on a hunt coordinator hunt, they will have their points restored
- An opportunity is considered:
 - Hunter declines offered non-emergency hunt
 - Two messages not returned by hunter in contact time frame
 - Inability to contact MH using info in WILD system

Master Hunter Advisory Group

Role

- Represents MHs statewide
- Consists of MHs from each Region
- Advises WDFW on issues and opportunities affecting MH and MHPP
- Helps WDFW conduct MH meetings targeting communities and stakeholders to help resolve local issues and concerns

Master Hunter Advisory Group

Mission Statement

 Develop a corps of hunters dedicated to preserving the heritage of hunting by giving back to the sport, displaying the highest standards of conduct, and working to conserve wildlife habitat and hunting opportunity.

MHAG Strategic Plan

- Developed by WDFW and MHAG subgroup
- Adopted by MHAG
- Focus areas:
 - Youth Hunts
 - Education and training for new and existing hunters
 - Improving the image of MHs and the MHPP

MHAG Strategic Plan

- Near-term Priorities:
 - Use MH skills and contacts to develop opportunities for youth where there is a good chance of success
 - Utilize MHs at public events like clinics, sports shows, seminars, etc.
 - Increase visibility of MHPP benefits and accomplishments to the public

MHAG Strategic Plan

- First Hunt Foundation
 - WDFW has decided to partner with First Hunt Foundation

Ethical (and Legal) Issues

- MHs are a very visible representation of the hunting community
- Landowners have experienced issues with Master Hunters, such as expecting access to private land, trespassing to hunt or retrieve down game, littering, gates not left as found, etc.
- The public watches and judges all Master
 Hunters by the actions they see, which is why
 you must follow all the highest ethical standards

Violations

- WDFW must:
 - Suspend a Master Hunter who pays the fine or is found guilty of an infraction of RCW 77.15 for two years
 - Suspend a Master Hunter who is found guilty of a misdemeanor, gross misdemeanor, or felony of RCW 77.15 for life

Violations

- Identified on license that they are a Master Hunter
 - Right under their birthdate MH Expires:
- If cited or charged, MHPP has to take action
- Ensure you are legally, safely, and ethically hunting and fishing
 - If it is legal but might be seen as unsafe or unethical, stay clear

Violation Examples

- Fishing violations
 - Barbed hooks
 - Undersize fish
 - Over limit
 - Closed area

Violation Examples

- Hunting violations
 - Wrong sex
 - Antler restrictions
 - Wastage
 - Closed season

Violation Examples

- Disobeying any other Department Rule
 - Not obeying signs
 - Parking infractions
 - Driving on closed lands
