WASHINGTON COASTAL DUNGENESS CRAB INDUSTRY NOTICE
March 16, 2020

SPECIAL MANAGEMENT AREA CHANGE:

The purpose of this notice is to inform you of changes to the Quinault Special Management Area (SMA). According to the terms of the 2019-20 State-Quinault Dungeness Crab Harvest Management Plan, the Primary SMA will revert to the Secondary SMA at 8:00 am March 18, 2020. This change will open the area from Raft River to Split Rock to state fishers. A 200-pot limit will be in place for the first 30-days this area is open.

Quinault:

A Quinault **secondary SMA** (SSMA) will be established at 8:00 a.m. on March 18, 2020. The area that remains closed to state fishers includes the area shoreward of a line approximating the 27-fathom depth curve between the mouth of the Copalis River (47°08.00) and Split Rock (47°24.50) according to the following coordinates:

- Northeast Corner (Split Rock): 47°24.50' N. Lat. 124°20.00' W. Lon.
- Northwest Corner: 47°24.50' N. Lat. 124°32.40' W. Lon.
- Southwest Corner: 47°08.00' N. Lat. 124°25.50' W. Lon.
- Southeast Corner (Copalis River): 47°08.00' N. Lat. 124°11.20' W. Lon.

There is a 200-pot limit in the area that opens to state fishers between Split Rock (47°24.50) and Raft River (47°28.00) shoreward of a line approximating the 27-fathom depth curve from 8:00 a.m. on March 18, 2020, through 8:00 a.m. April 17, 2020. Fishers must pre-register with WDFW prior to deploying gear in this area by one of the three following methods:

Makah:

We want to remind you that the Makah SMA, in the area between Destruction Island and the US Canada Border, is open (as of February 21, 2020.)

There is a 200-pot limit in this area until 8:00 A.M. March 22, 2020 (the first 30-days following the opening of this SMA). Fishers must pre-register with WDFW **twenty-four hours** prior to deploying gear in this area. Fishers can pre-register by one of the three following methods:

The Makah SMA is described as the coastal waters between 48°02.15 N' Lat. to 48°19.50 N' Lat. east of a line connecting those points approximating the 25-fathom line according to the following coordinates:

- Northeast Corner: Tatoosh Island
- Northwest Corner: 48°19.50' N. Lat. 124°50.45' W. Lon.
- Southwest Corner: 48°02.15' N. Lat. 124°50.45' W. Lon.
- Southeast Corner: 48°02.15' N. Lat. 124°41.00' W. Lon.

Quileute:

The Quileute SMA remains closed to state fishers. The Quileute SMA is described as the area from Cape Johnson to Destruction Island shoreward of a line approximating 30 fathoms according to the following points:

- Northeast Corner (Cape Johnson): 47°58.00' N. Lat. 124°40.40' W. Lon.
- Northwest Corner: 47°58.00' N. Lat. 124°49.00' W. Lon.
- Southwest Corner: 47°40.50' N. Lat. 124°40.00' W. Lon.
- Southeast Corner (Destruction Island): 47°40.50' N. Lat. 124°24.43' W. Lon.
