# Friday, October 23, 2020

Chair Carpenter called the meeting to order at 8:00 a.m.

## 1. Call to Order

# a. Commissioners' Discussion

Chair Carpenter mentioned that the #10 Hatchery reform item was struck from the agenda and Executive Session was moved from Saturday to Friday.

## **Wolf Committee**

# Commissioners in attendance: Anderson, Baker, Thorburn, Linville

The committee met October 12, 2020. Commissioner Thorburn reported that Julia Smith gave an update on post recovery planning efforts. University of Washington staff who are creating the population status modeling were unable to join but provided a written report identifying all the factors that will go into the model and how the data will be pulled together. They are on schedule and expected to see results next spring. Donny Martorello gave an update on the timeline for the Governors wolf rulemaking mandate.

## Wildlife Committee

Commissioner Thorburn reported the committee received an update from Hannah Anderson on the status of the Sage-grouse PSR and its 5-year deadline. Captain Myer and Eric Gardner discussed human-wildlife attack incidents. Anise Aoude reported on the current status of the hunting season 3-year package planning.

## **Habitat Committee**

Commissioners in attendance: Smith, Kehoe, Baker, Linville, Anderson

Commissioner Smith reported that Dana Oster and Lucas Hart from the Northwest Straits Commission provided a briefing on their Kelp Conservation and Recovery Plan. You can find the plan Lucas and Dana spoke about <a href="here">here</a>. Commissioners are interested in field visit opportunities, when available.

Habitat Director Margen Carlson updated the committee on the status of mineral prospect rulemaking. It's been pushed from December to January for a briefing and then a decision in February 2021.

Margen updated the committee on the following habitat grant programs:

- Brian Abbott Fish Barrier Removal Board (FBRB). Background about the Board, funded projects, and the 21-23 funding list can be found <a href="https://example.com/here">here</a>.
- National Estuary Program Strategic Initiatives. Additional information about Puget Sound's National Estuary Program can be found <a href="https://example.com/here">here</a>. There are three strategic initiatives, including stormwater, shellfish, and the habitat focus, led by WDFW and DNR. WDFW is getting ready to apply for the next installment of that federal agreement, which would authorize \$15-100 million over the next five years, pending Congress continuing to allocate the resources.

Staff will look at bringing a kelp management briefing to the full commission in January. Margen will send grant details to the committee for additional reading.

# 11. Willapa Bay Salmon Management Policy (C-3622) Comprehensive Review – Briefing, Public Comment

Chad Herring, Anadromous Resource Policy Analyst provided the Commission with a briefing on updated language to the comprehensive review document and seek Commission acceptance as a final report.

Commissioner McIsaac suggested that the acceptance of the final report be tabled until the Fish committee has had time to provide their feedback on the report and public input at the December Fish committee. He would like to see staff come back with the answers at Fish committee about the AhA modeling method. He also recommended a policy revision, a SEPA evaluation and a list of alternatives be provided to the Commission on the policy.

Commissioner Thorburn requested big picture guidance on parts of the policy. Several suggestions from the Commissions were: timing of commercial fisheries, species designation, chinook run in season model, exploitation ceilings and in season management.

# 12. Miscellaneous and Meeting Debrief

Commissioner Thorburn voiced concern over the agency's application with the conservation board. The agency already sits with the board as an advising capacity. This position could be perceived at threatening to other stakeholders.

Commissioner Linville reported that she had a conversation with Mike Livingston, DFW staff. He asked her about Shrub steppe habitat restoration. After her suggestions 932 acres of aril seed was laid by Swanson lake before a heavy snowfall, hopefully solidifying a first step in habitat recovery in that area.

Commissioners Kehoe asked some follow up questions about the kelp recovery presentation at the Habitat committee meeting. Commissioner Smith asked what the current volume being harvested is. Commissioner Baker suggested that staff reach out to the organization that gave the presentation and see what the Commission can do for them.

Commissioner McIsaac indicated there were a couple more areas for staff to address on the Columbia River decision document. It should be going out to the Commission and the public next week.

The Commission discussed next steps for Policy C-3619.

Commissioner McIsaac made a motion, seconded by Commissioner Kehoe that the Commission continue with the Policy C-3619 review process by noticing the public of a Fish Committee web conference for November 3 and a single- issue Commission web conference for November 5.

Some Commissioners were concerned with date selection wording of the motion. There was a consensus from the Commission that prompt action and direction from staff was critical to the process. Staff indicated they would respond with date availability on Monday, October 26, 2020 focused around the week of November 2-6, 2020 for a special Fish committee meeting and single-issue special Commission meeting.

## Commissioner McIsaac withdrew his motion.

Commissioner Graybill spoke positively of the collaborative efforts between the Yakama tribe and WDFW. On October 1, 202 the Coho season opened on the Icicle River. He was happy to report it was full of salmon and had the opportunity to catch one himself.

Chair Carpenter adjourned the meeting at 10:23 a.m.
