8. Commercial Whale Watching Position Statement—Briefing, Decision

Background summary:

In spring 2019, the Washington Legislature passed Senate Bill 5577: *a bill concerning the protection of Southern Resident Orca Whales from vessels*, which developed a license for commercial whale watching and directed the Washington Department of Fish and Wildlife (WDFW) to administer the licensing program and develop rules for commercial viewing of Southern Resident Killer Whales (SRKW). (See RCW 77.65.615 and RCW 77.65.620)

The purpose of creating rules for commercial whale watching of SRKW is to reduce the impacts of vessel noise and disturbance on the whales' ability to forage, rest, and socialize while enabling sustainable whale watching. The Commission adopted a comprehensive rule package on December 18, 2020.

Leading up to rule adoption, the Commission held a special meeting on December 15 where they also discussed adopting a policy statement that: 1) offered context about how this rule package fits within broader efforts to recover Southern Resident killer whales; 2) summarize best practices that were not being included in the rule package; and 3) consider other voluntary measures for the general public and recreational boaters. The policy statement was scheduled for consideration on December 18 meeting, but so were a lot of other agenda items, and this item was postponed until January 2021. Further, there was interest expressed by Commissioners on December 18 that they would like to have more time to review the draft document.

This agenda item will include a short staff orientation of the edits received over the past month on the draft document, followed by time set-aside for Commission deliberation and consideration of adopting the statement.
