Purpose of Game Management Plans

- Guide the Washington Department of Fish and Wildlife's management of hunted wildlife.
- Provide the public an opportunity to weigh-in through a formal process on high level game management issues.
- Identify data gaps and future research and monitoring needs.
- Identify existing and potential limiting factors affecting game populations.
- Give broad direction on addressing known limiting factors.
- Provide a basis for work planning.
- Identify funding needs.
- Provide direction on sustainable hunting management recommendations.



GMP Current Path Forward

- Commission will contemplate policy considerations that may inform or supersede individual plans – Prong 1
- Overarching plan and individual species and guild plans that will be produced to guide WDFW – Prong 2
- All plans will go through SEPA using a phased review approach
- Wildlife Committee/Commission will provide case appropriate review during the internal review process prior to public SEPA review
- Plans are not actions hunts go thru Commission Rulemaking process, other content may inform resource allocations

- Appropriate linkage to the Overarching Plan
- Will tie content to annual status and trend reports so those reports track the objectives and strategies in these plans

- Internal plan review including Wildlife Committee
- Comply with SEPA process
- Seek Commission approval on plans as they are completed
