The table above shows agency preferences between the comparative operating budget proposals.

The priority for the Department of Fish and Wildlife (WDFW) is the package for Restoring Washington's Biodiversity. WDFW's preference is the stair-step approach found in the House version of the 2023-25 Operating Budget. This approach includes \$8M in the first fiscal year and \$15M ongoing in the second.

WDFW also supports supplementing this approach with one-time Natural Climate Solutions account funding as proposed in the Senate 2023-25 Operating Budget. Climate impacts will accelerate risks to biodiversity and resilient landscapes. With funding from the Natural Climate Solutions account, WDFW would focus on the nature-based climate solution components of the authorizing language and identify actions that align with high benefit to wildlife species affected by the impacts of climate change. Research shows that healthy ecosystems are the most effective carbon sinks, and ecosystems in the process of restoration have a high carbon sequestration rate.

## **Onetime items, requested ongoing:**

The below items were requested ongoing, but funded onetime in the 2021-23 biennium, and are now at risk of being funded onetime again.

- EW/SRIP Riparian Systems Assessment
- EW/S4B Toutle & Skamania Hatcheries
- EW/A5A Salmon and Steelhead Monitoring
- EW/C4 Columbia River Pinniped Predation
- EW/A9 Streamflow Policy Support
- EW/A4A Salish Sea Marine Mammal Surveys
- EW/A5C Crab Fishery and Humpbacks
- EW/S11/S111 Prioritization of Fish Barriers
- EW/FP Fish Passage Rulemaking

**Recommendation:** Please fund the above items ongoing.

**Rationale:** Challenges in hiring "project" staff will put these items at risk of delays and possible failure to meet the Department's obligations set within the provisos and budget notes. Funding these items ongoing will allow the Department to keep staff needed for implementation. Further, in some instances, there is insufficient time to complete them within one biennium and WDFW will not be able to completely deliver the intended results.

**Recommendation:** Align with House.

**Rationale:** WDFW has worked closely with State Parks and the Department of Natural Resources and fully supports a multi-agency approach to delivering the desired outcome. The funding provided in the House budget for WDFW allows us to effectively engage in the joint process. We also support full funding for Parks and DNR.

**Recommendation:** Align with House.

**Rationale:** The Wolf Advisory Group and the Wolf-Livestock Protocol establishes a framework for the department's response when conflicts between wolves and livestock occur. It also serves to increase the transparency and accountability of the department's activities and management actions related to wolves.

FHF - Forest Health and Fuel Reductions	\$6,000	\$4,000	Senate

**Recommendation:** Align with Senate.

**Rationale:** The Forest Health and Fuel Reductions authority first arrived in the 2021-23 Capital budget was 95% spent by the 16<sup>th</sup> month of the biennium. The Governor's budget placed that authority in the operating budget for the next biennium. Due to rising costs, it will be spent even more quickly. Reduced Forest Health funding in the House proposed budget will result in a 40% drop in forest acres treated. Acres treated will be reduced by 20% due to lower timber market prices and increased hauling costs. Reduced funding will cause reduced forest health; higher wildfire risk; half-completed projects (restoration includes thinning and prescribed burning); and an inability to achieve goals in the 20-year Forest Health Strategic Plan.

**Recommendation:** Align with Senate.

**Rationale:** Each of these items include legally unavoidable costs, introduced at maintenance level. WDFW would need to reduce current activities to pay these increased costs or trade the difference for a line item above.
