Thursday, September 28, 2023

The Commission held a retreat with consultants from Triangle Associates. The topics that were focused on and discussed were commission processes, procedures, and Commissioner roles.

Friday, September 29, 2023

The Commission continued with their retreat until the regular meeting started at 1:00 pm.

1. Call to Order

a. Commissioners' Discussion

Chair Baker called the meeting to order at 8:00 a.m.

Commissioner Rowland attended a meeting in The Barn in Winthrop put on by several staff regarding a proposal to close some portions of the Methow Wildlife Area for deer winter range. Kudos to staff for a great presentation and interaction with the public. Great example of how well the department presents very difficult situations.

b. Meeting Minute Approval

- The Commission considered approval of the August 10-12, 2023, August 18, 2023 and September 8, 2023 meeting minutes.

Commissioner Smith made a motion, seconded by Commissioner Ragen, to approve the minutes from the August 10-12, 2023, hybrid meeting, as presented. All in favor. Motion passes.

c. Committee Reports - This Section constitutes the formal minutes from each of the listed committee meetings:

Fish Committee

Committee members in attendance: Anderson, Linville, Anderson, Parker

Staff provided a briefing on the Coastal Dungeness Crab and Puget Sound Shellfish Rulemaking. They discussed the background, actions to date, timelines, stakeholder comments and next steps. The committee also discussed the North of Falcon season planning. The North of Falcon Policy will need to be revised as needed by the end of the year. The discussed the next several months and timing of topics coming forward.

Executive Committee

3. Land Transactions - Briefing, Public Comment and Decision

Commissioner Anderson made a motion seconded by Commissioner Ragen to approve the land transactions as presented by staff. All in favor. Motion passes.

4. Willapa Bay Salmon Management Draft Policy Review – Decision

Staff requested that the Commission adopt revisions to the Willapa Bay Salmon Management Policy (C-3622) that directs salmon fishery management within Willapa Bay.

Commissioner Anderson made a motion seconded by Commissioner Ragen to approve the policy as presented by staff. All in favor. Motion passes.

5. Coastal Crab and Puget Sound Shellfish Rulemaking – Briefing, Public Hearing

Staff briefed the Commission and held a public hearing on rule proposals for coastal crab and Puget Sound shellfish.

Larry Thevik provided comments on the item.

The Commission briefly reviewed the tentative meeting dates for 2024.
