## Department recommendation for 3-year season setting for 2024-2026 seasons.

The Department recommends the following related to the current season setting process:

Open and delegate the following:

- Deer and elk general seasons and small and upland game seasons require revision on a three-year cycle, thus those rules must be revised.
- Migratory game birds and ungulate permit rules are revised annually and will also need to be revised this year.

Do not open and no changes this year:

• Leave the cougar and bear rules as is until the game management plan is complete, or the Commission creates a carnivore hunting policy.

As part of this three-year season setting process, we asked for internal and external ideas to consider for rule making. We have summarized these ideas and developed recommendations related to what should move forward for this year's rule making. To move an idea forward means that we will consider it for rule making and vet it through the public process. We recommend delegating the following proposals to the Director for rulemaking.
