There is a clear commission motion to not have spring bear hunts until a management-based need has been identified.

A management based need has been identified; the Black Bear Timber Damage Depredation Permit Program

The Department has been clear they may consider a management-based spring black bear hunt in the future after developing specific thresholds on which to base these recommendations, which may require additional guidance from the commission.

We all just watched the Commission spend months dealing with a management-based black bear hunt.

A management-based hunt also known as the Black Bear Timber Damage Depredation Permit Program.

The point of contention is the commission wants to give the hunting tags to timber owners experiencing damage.

Purpose, adjustment:

The purpose of amending WAC 220-440-210 is to clarify the text to clearly identify licensed bear hunters may directly apply to the department for a black bear depredation permit.

Rationale of this Petition:

Amend the Black Bear Timber Damage Depredation Permit Program permitting process from an intended private commercial timber owner process into a WDFW Managed Spring Black Bear Hunting Season.

Public comment overwhelmingly supported licensed bear hunters apply for the permits.

This petition requests WAC 220-440-210 be amended for the permits be issued to licensed bear hunters.
