



CONTRACT AMENDMENT

The above-referenced Contract between the State of Washington, Department of Fish and Wildlife (WDFW); and EVERYWHERE Communications, Inc. is hereby amended as follows:

- a. Paragraph a. of Section 2, Project Schedule/Deliverables for Conduct of Work, is revised to the following to allow for higher levels of services for new and enrolled Garmin GPS devices:

“The Contractor will provide to WDFW its Standard satellite service plan with dedicated short message service (SMS) for enterprise-wide management and communications through WDFW’s Garmin GPS devices. Standard satellite service includes:

- Up to 250 monthly messages
- A 5 minute message/track delivery rate
- 24/7 global SOS monitoring
- Custom message retention
- Geofences
- Scheduled location monitoring
- WhatsApp Notification
- Scheduled Check-ins
- Remote Check-ins
- A dedicated telephone number for each enrolled GPS device for SMS.”

- b. Section 3, Budget, is revised to allow for pricing at the Standard level for all enrolled GPS devices; add the Safeguard mobile app for WDFW-owned cellular telephones; allow for the purchase of GPSMap 67i and GPSMap 86I GPS devices; and to revise the costs for professional maintenance and training services resulting from an increase in enrolled Garmin GPS devices:

- “a. For Garmin GPS Standard satellite service plan with dedicated SMS, WDFW will reimburse the Contractor at a rate of \$599.40 per year/\$49.95 per month for each Garmin device enrolled. For Garmin devices enrolled under the Basic satellite service plan, WDFW will reimburse the Contractor at an additional rate of \$180.00 per year per year/\$18.00 per month (for a total of \$563.40 per year/\$49.95 per month) for each Garmin device previously enrolled. WDFW may select a different level of service for specific Garmin GPS devices as identified in order documents for services provided after June 30, 2025.

- b. For Garmin GPS devices and associated equipment WDFW will reimburse the Contractor at the manufacturer’s suggested retail price. WDFW may purchase up to 750 Garmin InReach Mini 2 devices estimated at \$400 each; 100 GPSMap67i devices estimated at \$599 each; 50 GPSMap 86i devices estimated at \$599 each; and 50 GPSMap 86sci devices at \$649 each. The Contractor will provide any discounts offered by the equipment manufacturer to WDFW.
 - c. For additional professional maintenance and training services WDFW will reimburse the Contractor WDFW will pay the Contractor \$46,406 per year. This cost is payable in advance and is based on 650 Garmin devices enrolled. WDFW will reimburse the Contractor at a rate of 15% of the value of each additional device enrolled prorated for the remainder of that year ending on June 30th. .
 - d. WDFW will reimburse the Contractor a one-time activation Iridium fee of \$30 per GPS device enrolled.
 - e. WDFW will reimburse the Contractor for use of the Safeguard app for cellular telephone communications with GPS devices at a rate of up to \$119.40 per year/\$9.95 per month per user account. The Contractor will reduce this rate by 20% for WDFW seasonal employee user accounts. WDFW seasonal employees are those employees with cyclical appointments at approximately the same time each year and last for a minimum of five months but less than twelve months in duration.”
- c. The maximum contract value is increased by \$2,150,000 for a new maximum value of \$2,850,000.

All other terms and conditions of this Contract remain in full force and effect.


