TO: Brad Smith, Chair, Fish and Wildlife Commission

NOW COMES the ADA Advisory Committee, by and through its Chairman, Reno Pellegrini, and conveys to the Commission as follows:

On June 13, 2016, the ADA Advisory Committee met, with quorum present, and discussed the matter of expanding damaged hunts for people with disabilities.

In as much as,

- there are currently approximately 86,000 active WILD profiles for persons with a record of disability, and the number of individuals increases each year; and

- the Commission and the Department are committed to providing equal opportunity to access all programs and services provided by the Department; and

- the Department has undertaken, at the regional level, to provide damaged hunt opportunities to hunters in this state;

NOW THEREFORE, the ADA Advisory Committee, by majority vote, has approved this motion, advising the Commission that it should consider expanding the opportunities to participate in damaged hunt opportunities for persons with disabilities.
