Dear Coastal Dungeness Crab Buyer:

The Washington Fish and Wildlife Commission recently approved rules regarding the use of electronic fish tickets. The rule changes, which will be implemented later this summer, include expansion of the requirement to use electronic fish tickets to include landings of directed Pacific halibut, groundfish deliveries from Alaska and British Columbia, and deliveries made by vessels conducting halibut and groundfish research. In addition, the rule also made the use of electronic tickets more widely available by authorizing the use of voluntary electronic reporting agreements with interested receivers of fish and shellfish.

These rule changes do not require electronic reporting for coastal Dungeness crab at this time, however, Washington Department of Fish and Wildlife (WDFW) staff would like to take the opportunity to introduce the electronic fish ticket program to Dungeness crab buyers that are not already familiar with it. WDFW will hold a workshop to provide an overview of the electronic ticket program so that interested crab buyers can participate in the voluntary reporting program when it becomes available later this summer.
