Directions and Access to the Natural Resources Building (NRB): From I-5, take State Capitol exit (105). The exit puts you on 14th Avenue. Go through the tunnel and turn right onto Capitol Way. Turn right onto 11th Avenue. Turn right onto Washington and left into the NRB visitor parking lot.

NRB Visitor Parking: Parking costs \$1.50 cents per hour, payable at the meters. Parking meters accept credit/debit card, \$1 bills or coins.

NRB Visitor Sign-in: You will need to sign in and pick up a visitor badge at the first floor information kiosk, then head up to the 5th floor, Room 579.

Directions to the Natural Resources Building

1111 Washington St. SE, Olympia WA 98501-2283

Southbound:

Take I-5 Exit 105A. Follow the "State Capitol" lane, which parallels the freeway, for 1/4 mile.

Northbound:

Take I-5 Exit 105. Keep to the LEFT following the "State Capitol" lane.

Go through the roundabout and the tunnel. At the first traffic light (Capitol Way), turn RIGHT. Turn RIGHT again at the next traffic light (11th Ave.). Just past the next traffic light (Washington St. SE), turn RIGHT once more into the Natural Resources Building parking garage. Following the orange signs just inside the garage, turn LEFT toward the uncovered parking area, then turn RIGHT to access the ramp leading up to the P-1 level. At the top of the ramp, turn RIGHT to access the visitor parking area, which is uncovered.

Parking costs \$1.50 per hour, weekdays 8 a.m. to 5 p.m., but is free on evenings and weekends. Parking fees can be paid by debit and credit cards, \$1 bills or coins.
