Introduction

The WDFW team was introduced by Kirsten. Kirsten led the group in a brief recap of the current Puget Sound Recreational Fishery seasons, which included MA-10 and MA-11 Coho and Pink Fisheries, as well as Snohomish River fisheries. She then covered an introduction to the PSRFEF Budget.

Questions raised:

There was interest in figuring out whether the Coho were resident or ocean-going in the current Coho fisheries. This could be based on the creel data and length distributions in the fishery.

PSE Distribution / License Sales

After the introduction, Hailey led the group through several slides outlining the Puget Sound Enhancement (PSE) participation and license sales.

- 2020 21 Participation: 20.107% (+/- 3.42%)
- 2019 20 Participation: 23.41% (+/- 33.1%)
- 2020 21 Number of Participants: 153,846
- 2019 20 Number of Participants: 160,526

License sales by fiscal year were discussed for 2019 – 2021 by license type.

Questions raised:

There was a question on why the license sales breakdown was from April – March when license sales end in November.

Current Budget

Next, Hailey led the group through a breakdown of the current budget, starting with Marking and Tagging investments at the different hatcheries. Next we discussed the Current Budget availability for new projects. And the current investments moving forward.

PSRFE Projects

Next, Kirsten, Hailey, and Joe walked through the projects suggested by WDFW during the May/June meetings. This included more details on the removal of Glenwood, the Oak Harbor Net Pens, Tagging of Hupp Coho, and continuing the Garrison Survival Study.
