


PSRFEF Budget

- PSRFEF brings in an average of \$2.8M each biennium or \$1.4M each fiscal year.
- Currently, ongoing projects take up 90% of funds.
- Currently PSRFEF is predicted to have between \$100- \$200k / BN in flexible funds for new projects.
- That figure could be higher if the Committee recommends adjusting longterm / ongoing project commitments.
