Purpose: The purpose of this emergency rule is to open recreational razor clam seasons.

EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.

Reasons for this finding: Survey results show that adequate clams are available for harvest in Razor Clam Areas 1, 3, 4 and 5 for recreational harvest. Washington Department of Health has certified clams from these Razor Clam Areas 1, 3, 4 and 5 to be safe for human consumption. There is insufficient time to adopt permanent rules.

NEW SECTION

WAC 220-330-16000K Razor clams – Areas and Seasons.

Notwithstanding the provisions of WAC 220-330-160, it is unlawful to take, dig for or possess razor clams taken for personal use from any beaches in any razor clam area except as provided for in this section:

- (1) Effective 12:01 p.m. January 22 through 11:59 p.m. January 28, 2024, razor clam digging is permissible in Razor Clam Areas defined in WAC 220-330-160 during evening tides on dates and times listed below:

Razor Clam Area	Date	Time
Area 1	January 23 through 27	From 12:01 p.m. to 11:59 p.m.
Area 2	Closed	Closed
Area 3	January 23 through 26	From 12:01 p.m. to 11:59 p.m.
Area 4	January 24, 25, and 28	From 12:01 p.m. to 11:59 p.m.
Area 5	January 22, 23, 26 and 27	From 12:01 p.m. to 11:59 p.m.
Area 6	Closed	Closed
Area 7	Closed	Closed

- (2) It is unlawful to dig for razor clams at any time in the Long Beach and Copalis Beach Clam sanctuaries defined in WAC 220-320-130.
