Purpose: The purpose of this emergency rule is to close the commercial beach seine fishery in Puget Sound Salmon Management and Catch Reporting Area 12C on September 3.

EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

Reasons for this finding: This rule is necessary to close Puget Sound Salmon Management and Catch Reporting Area 12C September 3. Hoodspout Hatchery Chinook returns are trending behind broodstock goals with approximately 800 fish currently on hand at the hatchery. This temporary closure of commercial beach seine harvest is needed to ensure that broodstock goals are met.

There is insufficient time to adopt permanent rules.

WAC 220-354-21000N Puget Sound salmon—Beach Seine—Open periods.
