EMERGENCY RULE

Reasons for this finding: This rule is necessary to open a commercial beach seine season in Puget Sound Salmon Management and Catch Reporting Area 12C on September 9. Hoodspout Hatchery Chinook returns are currently on track to meet broodstock escapement goals. This temporary opening of commercial beach seine harvest is needed to attain harvest objectives. There is insufficient time to adopt permanent rules.
